I, the undersigned Official Veterinarian authorized hereby certify that:

- 1. The product meets the requirements of the exporting country Laws and Regulations and may be freely sold for animal feeding in the said country.
- 2. The product / s was / were produced under the supervision of an official or accredited veterinarian.

- 3. No cases of foot and mouth disease, swine vesicular disease, rinderpest, African swine fever, Classical swine fever, Notifiable avian influenza and Newcastle disease have been diagnosed within a radius of 30 kms from the processing plant during the last 6 months prior to shipment.

- 5. The product has been manufactured and packed complying with approved manufacturing practice, sufficient to render it free from pathogenic microorganisms;
- 6. The product was analyzed by a random sampling of at least five samples from each processed batch taken during or after storage at the processing plant and complies with the following standards²:

Salmonella: absence in 25 g: n = 5, c = 0, m = 0, M = 0

Enterobacteriaceae: n = 5, c = 2, m = 10, M = 300 in 1 g.

- 7. The finished product does not contain and is not contaminated with commodities that should not be traded as defined in the B.S.E chapter of the OIE Terrestrial Animal Health Code³.
- 8. a. The end product was packed in new packaging material⁴, or
 - b. In case of dispatch as bulk transport, containers or any other means of transport were thoroughly cleaned and disinfected with a disinfectant approved by the competent authority before use;
- 9. The finished product was stored in enclosed storage and has undergone all precautions to prevent contamination with pathogenic agents after treatment.

Article 11.5.13 OIE Terrestrial Animal Health Code, 2010: Recommendation on ruminant-derived meat-and-bone meal or greaves

Ruminant-derived meat-and-bone meal or greaves from a negligible BSE risk country where there has been an indigenous case of BSE, should not be traded if such products were derived from cattle born before the date from which the ban on the feeding of ruminants with meat-and-bone meal and greaves derived from ruminants had been effectively enforced.

Ruminant-derived meat-and-bone meal or greaves from a controlled or undetermined BSE risk country, zone, or compartment.
